The owner of any dog(s) FIVE months of age or older shall annually obtain a license from the Village Clerk/Treasurer. The licensing year is January 1<sup>st</sup> – December 31<sup>st</sup>. A \$20 late fee per dog will be imposed and a citation may be issued if the dog is not licensed by March 31<sup>st</sup>. Please complete the form below and send along with a copy of the rabies certificate and appropriate fee to the Village of Lake Hallie, 13136 30<sup>th</sup> Avenue, Chippewa Falls WI 54729. New tags for the following licensing year are available prior to the December 31<sup>st</sup> expiration date.

## Ordinance 5.1.04

### Ordinance Relating to Dogs (Domestic and Exotic Animals)

The Village Board of the Village of Lake Hallie does ordain as follows:

#### Section 1 – Dog Licenses Required.

##### (a) Fees/Penalties.

No person in the Village of Lake Hallie shall own, harbor or keep any dog more than **five (5) months** of age within the Village of Lake Hallie without first obtaining a license from the Village Clerk/Treasurer or other authorized agent of the Village of Lake Hallie by application. The annual license fee shall be **ten dollars (\$10.00)** for each **spayed or neutered dog** and **twenty dollars (\$20.00)** for each **un-spayed or un-neutered dog**. A late fee in accordance with State Statutes shall be applied per dog after March 31<sup>st</sup> of each year. Exemptions to the license fee shall be granted in accordance with Wisconsin Statutes 174.054 or 174.055.
